ICHOM DEVELOPS THE STANDARD SETS COLLABORATIVELY, BRINGING TOGETHER LEADING PHYSICIANS, REGISTRIES AND PATIENT REPRESENTATIVES FROM ALL OVER THE GLOBE. ICHOM THEN DRIVES THE ADOPTION OF THESE STANDARDS TO ENABLE HEALTH CARE PROVIDERS GLOBALLY TO COMPARE, LEARN AND IMPROVE.**
