ICHOM Membership Terms and Conditions

ICHOM membership runs for 12 months, renews automatically each year, and can be cancelled at any time before renewal. Membership benefits include access to learning events, community opportunities, and member resources.

Effective Date: March 2026

These Terms and Conditions (“Terms”) govern participation in the ICHOM Membership Program. By applying for or maintaining membership, you agree to these Terms.

1. Definitions

For the purposes of these Terms:

- “**ICHOM**” refers to the International Consortium for Health Outcomes Measurement.
- “**Member**” refers to an individual whose membership application has been approved and whose membership is active.
- “**Membership**” refers to participation in the ICHOM Membership Program and access to associated benefits.
- “**Membership Term**” refers to the twelve (12) month period beginning on the date of activation.

2. Membership Term

Membership is valid for **12 months from the date of activation** and operates on a **rolling annual basis**.

Membership will **automatically renew each year** unless cancelled before the renewal date.

2. Application and Approval

All membership applications are **subject to review and approval by ICHOM**.

Applicants must select the appropriate membership category when applying (for example: Industry, Provider, Patient, or Student/Trainee).

ICHOM may verify eligibility and request additional information before approving an application.

Membership becomes active once:

- The application is approved, and
- The applicable membership fee has been paid.

3. Membership Fees and Payment

Membership fees are:

- Charged **annually**
- Payable in **USD**
- Processed via **Stripe or another authorised payment provider**

Membership will **automatically renew annually** unless cancelled prior to the renewal date.

Members will receive **at least 30 days' notice** before renewal.

4. Cancellation and Refunds

Members may cancel their membership at any time. Cancellation will prevent future renewals but will not affect the current membership term.

Membership fees are **non-refundable once membership has been activated**.

Where applicable, ICHOM may provide a **14-day cooling-off period** after activation during which a member may cancel for a full refund, provided member benefits have not been materially accessed.

7. Member Conduct

To the fullest extent permitted by law, ICHOM shall not be liable for indirect or consequential losses arising from participation in the membership program.
